<b>1</b>	The forms in the RFQ refer to <i>notarization</i> to suggest foreign companies. In the case of locally owned organizations may the same be replaced with <i>Commissioning</i> or is there a different set of forms to be used?	Clause 4.1.2.5 specifies that the forms are to be notarized where they are executed outside Kenya. Any form executed within Kenya may be commissioned by a Commissioner for Oaths.
<b>2</b>	In reference to PPP Project, having not had any successful project taken off in Kenya. Can the technical expertise be matched with other projects of equal value?	Please note that the PPP experience requirement) was amended by the Addendum to the RFQ dated 12 <sup>th</sup> February, 2017.
<b>3</b>	Does the aggregate experience in No 2 (a) (i) and 2 (b) (i) only refer to that of the contractor or of the entire construction project team including professionals?	The aggregate experience referred to in no. 2 (a) (i) and No. 2 (b) (i) of Appendix 1: Minimum Qualification Requirements refers to the aggregate experience of the Prospective Bidder (if a single entity) or the Consortium Member (for a Prospective Bidder who is a Consortium) who is proposed to meet the PPP Experience and the Construction Experience.
<b>4</b>	Clarify the 2 (a) (iii). Is the evidence of payment from the contractor or from the financier in the case of consortium?	The evidence of payment referred to in No. 2 (a) (iii) of Appendix 1: Minimum Qualification Requirements refers to payments made by third users using the services/facilities provided by the Eligible PPP Project to be considered.
<b>5</b>	Is there missing information on No. 3 (c)?	Note that item 3 (c) was left blank in the original RfQ document. There is no missing information. This was clarified in the Addendum to the RFQ dated 12 <sup>th</sup> February, 2017.
<b>6</b>	I would like to have a clarification on the consortium-I do not see anywhere who forms the consortium. Can i please have a breakdown of the consortium members? ( eg, Architect, QS, Engineer, Landscape etc)	The Prospective Bidders are encouraged to determine the Consortium Members who will meet the minimum qualification requirements and who will provide the necessary technical experience. The RFQ does not intend to dictate who should form part of such Consortium.
