## **SECTION 1- INVITATION FOR PREQUALIFICATION**

1. South Eastern Kenya University (SEKU) now invites qualified bidders to submit sealed applications for Pre-qualification of suppliers for the financial years 2018 - 2020

3. Enterprises willing to be considered under the procurement preferences for youth, women and persons with disabilities are requested to follow the link -[www.seku.ac.ke](http://www.seku.ac.ke) and download the documents listed therein for completion. In addition to fulfilling the requirements listed, they **MUST** fully comply with the requirements as stipulated by the National Treasury Office circular regarding tenders ([www.treasury.go.ke](http://www.treasury.go.ke)).
4. The documents are available free of charge and **MUST** only be obtained from the website link listed above and are not available from any other administrative offices of the University.
5. A single application is required per category. Those wishing to be considered for pre-qualification in more than one category should submit separate applications per category.
6. To be eligible, the applicant must prove that they qualify to participate in public procurement by providing all the documents as listed in the evaluation criteria under preliminary and mandatory requirements.
7. The candidates will thereafter have to prove their competency by fully complying with the instructions as listed in the Evaluation criteria under detailed evaluation.
8. The duly completed documents must be submitted in a sealed envelope clearly marked with the respective reference number and name. You are hereby requested to note that incorrectly addressed envelopes will not be opened.
9. All the successful candidates will be appropriately notified through the approved channels as directed by the Public Procurement Regulatory Authority.
10. This prequalification does not amount to any contractual obligation on the part of South Eastern Kenya University, and the

University is not obliged to invite any tenders or quotations from all the candidates that have expressed their interest in responding to this invitation.

11. South Eastern Kenya University has the right to invite open Tenders for goods or services in any of the categories as and when required in line with the Public Procurement Disposal Act and the regulations and the amendments thereafter.
12. South Eastern Kenya University reserves the right to authenticate information provided herein without reverting to the candidates.

## SECTION II - INSTRUCTIONS TO CANDIDATES

### 2.1 Scope of Tender

South Eastern Kenya University (hereinafter referred to as the procuring entity) intends to prequalify suppliers for the supply and delivery of goods and services for various categories .It is expected that prequalification applications will be submitted to be received by the procuring entity not later than **17<sup>TH</sup> May 2018 10:00AM**

All suppliers currently pre-qualified should note that they too have to re-apply afresh as all other previous pre-qualifications shall stand cancelled on **17<sup>th</sup> May 2018**. Only Persons and Enterprises qualifying under the procurement preferences for Youth, Women and Persons with disabilities have been officially notified by the procuring entity in writing need not re- apply.

### 2.2 Submission of Application

2.2.1 Applications for prequalification shall be submitted in plain sealed envelopes clearly marked with the category name and code number and deposited in the tender box situated at the Administration Block, South Eastern Kenya University, Main Campus so as to be received on or before **17<sup>th</sup> May 2018** at 10.30am.

2.2.2 Incorrectly addressed envelopes will NOT be opened. Late submissions will also NOT be accepted.

2.2.3 All the information requested for shall be provided in English Language.

2.2.4 Failure to provide information that is essential for effective evaluation of the applicant's qualification, or provision of false information and documentation, will result in the application being disqualified.

### 2.3 Eligible Candidates

2.3.1 This invitation for pre-qualification is open to all candidates who are eligible as defined in Kenya's Public Procurement Law and as indicated in the tender document.

2.3.2 The procuring entity's employees, committee members, board members and their relatives (spouse and children) are not eligible to participate in the tender

2.3.3 All Applicants found capable shall be prequalified.

## 2.4 Qualification Criteria

2.4.1 Pre-qualification will be based on meeting the minimum requirements to pass in the criteria set as shown in section v of this document. The declaration will either pass or fail based on the applicant's letter of application, mandatory requirements, company information, capability and litigation history

2.4.2 South Eastern Kenya University requires that tenderers observe highest standards of ethics during the selection and execution of contracts. The following rules will apply:

(a) South Eastern Kenya University will reject a tender for prequalification if it determines that a tenderer has engaged in corrupt or fraudulent activities in competing for the contract in question.

(b) We will have the right to inspect the business premises of the tenderer as and when required under PPOA regulations.

(c) We will declare the tender ineligible for pre-qualification if at any time South Eastern Kenya University determines that the tenderer is related to an employee of the University or a Council member unless otherwise pre-declared to avoid conflict of interest.

(d) We will declare a tender ineligible for prequalification if at any time, it determines that the tenderer has committed an offence relating to procurement, has breached regulations for procurement before in another public entity, has in procurement proceedings given false information about its actions and has been debarred or been blacklisted before by another public entity.

2.4.3 Litigation history: the applicant should provide accurate information on any litigation or arbitration resulting from contracts completed or under its execution over the last five year

### Phase 2-Mandatory Evaluation Phase

Screening shall be done to determine compliance to the following mandatory requirements

- Certificate of Incorporation/Registration
- Copy of Valid Tax Compliance Certificate
- VAT Certificate
- PIN Certificate
- Valid Trade Licenses

Failure to provide the mandatory documents tabulated will lead to disqualification
